CONDITIONS OF CARRIAGE

In tendering the shipment for carriage the customer agrees to these terms and conditions of carriage and that this is irrevocable and non-transferable. The customer or its authorized agent shall be bound by these conditions. ARAMEX includes Aramex Co Ltd of operating divisions and subsidiaries in America Ltd and their respective agents, offices and employees.

1. SCOPE OF CONDITIONS
These conditions shall apply to all services provided by ARAMEX. THE CUSTOMER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX shall not be bound by any agreement which varies from these conditions unless such agreement is in writing and signed by an authorized agent of ARAMEX. The absence of such written agreement shall constitute the entire agreement between ARAMEX and each of its customers.

2. ARAMEX'S OBLIGATIONS
ARAMEX agrees, subject to receiving payment of applicable rates and charges in full on the date of acceptance by ARAMEX of a shipment to arrange for the transportation of the shipment to the destination agreed upon by ARAMEX and the customer. ARAMEX reserves the right to require the customer to pay for the transportation by any route and procedure and by successive carriers and according to its own handling procedure and transportation methods.

3. SERVICE RESTRICTIONS
ARAMEX reserves the right to refuse any documents or parcels from any customer company at its own discretion. ARAMEX reserves the right to abandon carriage of any shipment at any time after acceptance when such shipment could possibly cause damage or delay to other shipments or an arrival or when any such carriage is prohibited by law or is in violation of any of the rules contained herein. ARAMEX reserves the right to open and inspect any shipment consigned by a customer to ensure that it is capable of carriage to the state or country of destination within the standard customs procedures and handling methods of ARAMEX. ARAMEX does not warrant that any particular item to be carried is capable of carriage without infringing the law of any country or state through which the item may be carried.

4. LIMITATION OF LIABILITY
Subject to factors a) and b) below:
a) ARAMEX will be responsible for the customer's shipment only while it is within ARAMEX custody and control. ARAMEX shall not be liable for loss or damage of a shipment while in possession of the carrier or the carrier's agent or sub-agent. ARAMEX'S LIABILITY IS IN ANY EVENT LIMITED TO ONE HUNDRED DOLLARS (US\$100.00) or its equivalent per shipment unless a higher value is declared on the Aramex bill at the time of tender and an additional charge is paid. Reinsurance and determined by ARAMEX for such as Hundred Dollars (US\$100.00) or the actual value of the shipment as declared by the customer on the Aramex bill, whichever is less. The actual value of the shipment shall be the actual value of the shipment at the time of tender and not the actual value of the shipment at the time of loss. b) Notwithstanding any of the foregoing, the maximum amount payable by ARAMEX in respect of any shipment accepted by ARAMEX is TEN THOUSAND DOLLARS (US\$10,000.00) AND IN NO EVENT SHALL THE LIABILITY OF ARAMEX EXCEED THAT AMOUNT.

5. CONSEQUENTIAL DAMAGES EXCLUDED
ARAMEX SHALL NOT BE LIABLE IN ANY EVENT, FOR ANY CONSEQUENTIAL, SPECIAL OR INCIDENTAL DAMAGES OR OTHER INDIRECT LOSS HOWEVER ARISING, WHETHER OR NOT ARAMEX HAS BEEN ADVISED THAT SUCH DAMAGES MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO LOSS OF INCOME, PROFITS, INTEREST, UTILITY OR LOSS OF MARKET.

6. LIABILITY NOT ASSUMED
ARAMEX shall not be liable for any loss, damage, delay, misdelivery or non-delivery not caused by its own negligence or that of its employees, agents, subcontractors or other parties who are engaged by ARAMEX for any loss, damage, delay, misdelivery or non-delivery caused by:
a) the act, fault or omission of the shipper or consignee or any other party who claims an interest in the shipment
b) the nature of the shipment or any other circumstances which are inherent in the shipment
c) violation by the shipper or consignee of any terms or conditions stated herein including, but not limited to improper or insufficient packing, securing, marking or addressing, misdescribing the contents of any shipment, or failure to observe any of these rules relating to the shipment not acceptable for transportation whether such rules are now or hereafter promulgated by ARAMEX.

7. ACTS OF GOD
ARAMEX shall not be liable for any loss, damage, delay, misdelivery or non-delivery of a shipment caused by any act of God, including but not limited to fire, lightning, explosion, riot, strike, sabotage, terrorism, war, insurrection, rebellion, piracy, hostilities, civil or military disturbances, or other events beyond the control of ARAMEX. ARAMEX shall not be liable for any loss, damage, delay, misdelivery or non-delivery of a shipment caused by any act of God, including but not limited to fire, lightning, explosion, riot, strike, sabotage, terrorism, war, insurrection, rebellion, piracy, hostilities, civil or military disturbances, or other events beyond the control of ARAMEX. 8. WHILE ARAMEX UNDERTAKES TO EXERCISE ITS BEST EFFORTS TO DELIVER EXPEDITIOUS DELIVERY IN ACCORDANCE WITH REGULAR DELIVERY SCHEDULES, ARAMEX WILL NOT UNDER ANY CIRCUMSTANCES BE LIABLE FOR DELAY IN PICKUP, TRANSPORTATION OR DELIVERY OF ANY SHIPMENT REGARDLESS OF THE CAUSES OF SUCH DELAY.

9. MATERIALS NOT ACCEPTABLE FOR TRANSPORT
ARAMEX will not accept for transport any material which is not accepted by ARAMEX. The customer's responsibility to accurately describe the shipment on this bill and to ensure that no material is delivered to ARAMEX which has been declared to be unacceptable by ARAMEX.

10. PACKAGING
The packaging of the shipment, documents or goods for transportation is the customer's responsibility including the placing of the goods or documents in any container which may be supplied by the customer to ARAMEX. ARAMEX accepts no responsibility for loss or damage to documents or goods caused by inadequate or inappropriate packaging. The sole responsibility of the customer to address adequately each shipment of documents or goods to enable effective delivery to ARAMEX shall not be liable for delay in forwarding or delivery resulting from the customer's failure to comply with its obligations in this respect.

11. CUSTOMER'S LIABILITY
The customer is liable for all expenses and charges arising as a result of its failure to comply with its obligations under this agreement as a result of its negligence.

12. CHARGES
Any rates charged by ARAMEX for carriage are inclusive of fuel, port charges, taxes, levies, import duties, levies, import deposits or cartage incurred in respect of carriage of the customer's goods. Should the customer indicate by endorsement in the space provided on the bill that the receiver shall be liable for any or all such charges, the receiver shall be liable for such costs duty in the event of a default in payment by the receiver. ARAMEX will not be liable for any penalties imposed or loss or damage incurred due to the customer's failure to comply with its obligations in this respect.

13. PROPERTY
ARAMEX will only carry documents or goods which are the property of the customer and the customer warrants that it is authorized to accept and is accepting these conditions not only on behalf of itself but also on behalf of all other persons who are or may hereafter be interested in the documents or goods hereby undertaken by ARAMEX. ARAMEX shall be liable for any damage, costs and expenses resulting from any breach of this warranty.

14. CLAIMS
ANY CLAIMS AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED, WITHIN SIXTY (60) DAYS OF THE DATE OF ACCEPTANCE BY ARAMEX.

15. NON-DELIVERY OF SHIPMENT
Notwithstanding the shipment instructions to the contrary, the shipper shall be liable for all costs and expenses related to the shipment of the goods, whether incurred in either returning the shipment or warehousing the shipment pending disposition.

16. INSURANCE
a) ARAMEX maintains cargo liability insurance to the full extent of the liability offered to the shipper.
b) At the request of the shipper and upon payment therefore at the time of presentation of the bill, ARAMEX will arrange insurance coverage on behalf of the shipper to an amount not exceeding the actual value of the shipment (US\$100,000.00).
c) The insurance cover shall be governed by all the terms and conditions contained in the policy of insurance issued by the insurer. ARAMEX shall not be liable for any loss or damage to the shipment.
d) CONSEQUENTIAL DAMAGES AND LOSS OR DAMAGE RESULTING FROM DELAYS IN TRANSPORTATION ARE NOT COVERED BY ANY SUCH POLICY OF INSURANCE.

17. WARSAW CONVENTION
Where the rules relating to liability established by the Warsaw convention or the Montreal convention apply, carriage liability is governed by and shall be limited in accordance with such rules. Subject to applicable law where the Warsaw convention or the Montreal convention do not apply, liability for loss or damage is governed by these terms and conditions and shall be limited to the amount stated on the bill of lading (US\$100,000.00). THIS IS A NON-NEGOTIABLE ARAMEX SERVICE PROVIDED AND SUBJECT TO THE TERMS AND CONDITIONS SET FORTH ON THE REVERSE OF SHIPPER'S COPY. BY SIGNING THIS BILL, THE SHIPPER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX'S LIABILITY IS LIMITED TO US\$100,000 IN TENDERING THIS SHIPMENT. SHIPPER AGREES THAT ARAMEX SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE CARRIAGE HEREOF. ARAMEX DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED WITH RESPECT TO THIS SHIPMENT.
