CONDITIONS OF CARRIAGE

In tendering the shipment for carriage the customer agrees to these terms and conditions of carriage and that they are irrevocable and have been prepared by the customer or on the customer's behalf by ARAMEX used in these conditions. ARAMEX includes Aramex Co Ltd all operating divisions and subsidiaries of Aramex Ltd and their respective agents/agents officers and employees.

1. SCOPE OF CONDITIONS  
These conditions shall govern and apply to all services provided by ARAMEX SIGNING THIS AIRBILL, THE CUSTOMER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX shall not be bound by any agreement which varies from these conditions unless such agreement is in writing and signed by an authorized officer of ARAMEX. The absence of such written agreement does not constitute the entire agreement between ARAMEX and each of its customers. Employees of ARAMEX shall have the authority to alter or waive these terms and conditions as stated herein.

2. ARAMEX'S OBLIGATIONS  
ARAMEX agrees, subject to receiving payment of applicable rates and charges in effect on the date of acceptance by ARAMEX of a shipment to arrange for the transportation of the shipment between the locations agreed upon by ARAMEX and the customer.  
ARAMEX reserves the right to transport the cargo/shipment by any route and procedure and by successive carriers and according to its own handling, storage and transportation methods.

3. SERVICE RESTRICTIONS  
a) ARAMEX reserves the right to refuse any documents or parcels from any person or company at its own discretion.  
b) ARAMEX reserves the right to abandon carriage of any shipment at any time after acceptance when such shipment could possibly cause damage or delay to other shipments, equipment or personnel or when any such carriage is prohibited by law or is in violation of any of the rules contained herein.  
c) ARAMEX reserves the right to inspect any shipment consigned by a customer to ensure that it is capable of carriage to the state or country of destination within the standard customs procedures and handling methods of ARAMEX. ARAMEX does not warrant that any particular item to be carried is capable of carriage without infringing the law of any country or state through which the item may be carried.

4. LIMITATION OF LIABILITY  
Subject to Section 6 and 6 hereof:  
a) ARAMEX will be responsible for the cargo/shipment only while it is within ARAMEX custody and control. ARAMEX shall not be liable for loss or damage of a shipment while responsibility is out of ARAMEX custody or control. ARAMEX'S LIABILITY IN ANY EVENT IS LIMITED TO ONE HUNDRED DOLLARS (US\$100/00) or its equivalent per shipment unless a higher value is declared on the Airway Bill at the time of tender and an additional charge is paid. ARAMEX shall not be liable for loss or damage of a shipment unless a higher value is declared on the Airway Bill at the time of tender and an additional charge is paid. b) Notwithstanding the foregoing, the maximum insured value on any shipment accepted by ARAMEX is TEN THOUSAND DOLLARS (US\$10,000.00) AND IN NO EVENT SHALL THE LIABILITY OF ARAMEX EXCEED THAT AMOUNT.

5. CONSEQUENTIAL DAMAGES EXCLUDED  
ARAMEX SHALL NOT BE LIABLE, IN ANY EVENT, FOR ANY CONSEQUENTIAL OR SPECIAL OR INCIDENTAL DAMAGE OR OTHER INDIRECT LOSS HOWEVER ARISING, WHETHER OR NOT ARAMEX HAD KNOWLEDGE THAT SUCH DAMAGE MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO, LOSS OF INCOME, PROFITS, INTEREST, UTILITY OR LOSS OF MARKET.

6. LIABILITY NOT ASSUMED  
ARAMEX shall be not liable for any loss, damage, delay, misdelivery or non-delivery of a shipment caused by:  
a) the act/omission of the shipper or consignee or any other party who claims an interest in the shipment;  
b) the nature of the shipment or any defect/condition of the same; or  
c) violation by the shipper or consignee of any term or condition stated herein including, but not limited to, improper or insufficient packing, securing, marking or addressing, misdescribing the contents of any shipment or failure to observe any of these rules relating to the shipment not acceptable for transportation whether such rules are now or hereafter promulgated by ARAMEX.  
d) Acts of God, piracy, civil war, insurrection, riot, rebellion, strike, sabotage, terrorism, acts of war, or other local disturbances or incidents to a state or weather conditions, temperature or atmospheric changes or conditions or other delay off any aircraft.  
e) Acts or omissions of any postal service/forwarder or any other entity to whom a shipment is tendered by ARAMEX for transportation, regardless of whether the shipper requested or had knowledge of such third party delivery requirement.  
f) Electrical or magnetic injury, or other such damage to electronic or photographic images or recordings in any form due to insects or vermin.  
g) While ARAMEX will endeavor to exercise its best efforts to provide expeditious delivery in accordance with regular delivery schedules, ARAMEX will not be under any circumstances liable for delay in transportation or delivery off any shipment regardless of the causes off such delay.

7. MATERIALS NOT ACCEPTABLE FOR TRANSPORT  
a) ARAMEX will notify customer from time to time as to certain classes of materials which are not accepted by ARAMEX. The customer is responsible to accurately describe the shipment on this Airbill and to ensure that no material is delivered to ARAMEX which has been declared to be unacceptable by ARAMEX.  
b) ARAMEX will not carry:  
flammables, balloons, works off art, negotiable instruments in bearer form, jewelry, precious metals, stones, pearls, low obscene or pornographic material, hazardous or combustible material, currency, stamps, deeds, travelers checks, industrial carbon and diamonds, cashier's checks, money orders, animals, antiques, games.  
c) In the event that any customer should consign to ARAMEX any such materials described above, or any item which the customer has undervalued for customs purposes or misdescribed whether intentionally or otherwise, the customer shall indemnify and hold ARAMEX harmless from all charges, fines and expenses arising in connection therewith. ARAMEX shall have the right to abandon such property and/or release possession off said property to any agent or employee off any national or local government claiming jurisdiction over such material. Immediately upon ARAMEX obtaining knowledge that such materials infringe these conditions have been turned over to ARAMEX, shall be free to exercise any off its rights reserved to it under this section without incurring liability whatsoever to the customer.  
8. PACKAGING  
The packaging off the cargo/documents or goods for transportation is the customer's responsibility including the placing off the goods or documents in any container which may be supplied by the customer. ARAMEX accepts no responsibility for loss or damage to documents or goods caused by inadequate or inappropriate packaging by the customer. The responsibility off the customer to address adequately each shipment off documents or goods to enable effective delivery to ARAMEX shall not be liable for delay in forwarding or delivery resulting from the customer's failure to comply with its obligations in this respect.  
9. NEGLIGENCE  
The customer is liable for all loss/damage and expenses arising as a result off its failure to comply with its obligations under this agreement as a result off its negligence.  
10. CHARGES  
Any rates charged by ARAMEX for carriage are inclusive off local airport taxes exclusive off any value added tax, duties, levies, imposts, deposits or outlays incurred in respect off carriage off the customer's goods. Should the customer indicate by endorsement in the space provided on the airbill that the receiver shall be liable for any customs duties, the customer shall be liable for such customs duty in the event off a default in payment by the receiver. ARAMEX will not be liable for any penalties imposed or loss or damage incurred due to the customer's omissions or goods being impounded by customs or similar authorities and the customer hereby indemnifies ARAMEX against such penalty or loss.  
11. PROPERTY  
ARAMEX will only carry documents or goods which are the property off the customer and the customer warrants that it is authorized to accept and is accepting these conditions not only on behalf off itself but as agent and on behalf off all other persons who are or may hereafter be interested in the documents. The customer hereby undertakes to indemnify ARAMEX against any damages costs and expenses resulting from any breach off this warranty.  
12. CLAIMS  
ANY CLAIMS AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED WITHIN SIXTY (60) DAYS OF THE DATE OF ACCEPTANCE BY ARAMEX.  
13. NON-DELIVERY OF SHIPMENT  
Notwithstanding the shipping restriction to the contrary, the shipper shall be liable for all costs and expenses related to the shipment off the loss or costs incurred in either returning the shipment or warehousing the shipment pending disposition.  
14. INSURANCE  
a) ARAMEX maintains cargo liability insurance to the full extent off the liability offered to the shipper.  
b) At the request off the shipper and upon payment thereoff at the then prevailing ARAMEX will arrange insurance coverage on behalf off the shipper in an amount not exceeding Ten Thousand Dollars (10,000.00).  
c) The insurance cover shall be governed by all the terms and conditions contained in the policy off insurance covered by insurance carrier/intermediate. ENDORSEMENT covering such insurance will be made available to the shipper.  
15. CONSEQUENTIAL DAMAGES AND LOSS OR DAMAGE RESULTING FROM DELAYS IN TRANSPORTATION ARE NOT COVERED BY ANY SUCH POLICY OF INSURANCE.  
16. WARSAW CONVENTION  
Where the rules relating to liability established by the Warsaw convention or the air convention apply, the carrier's liability is governed by and shall be limited to accordance with such rules. Subject to applicable law where the Warsaw convention or the air convention do not apply, the carrier's liability is governed by these terms and conditions and shall be limited to proper damages up to an amount not exceeding (US\$10,000) shipment.  
THIS IS A NON-NEGOTIABLE AIRBILL. AS SERVICES PROVIDED ARE SUBJECT TO THE TERMS AND CONDITIONS SET FORTH ON THE REVERSE OF SHIPPER'S COPY. BY SIGNING THIS AIRBILL, THE SHIPPER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX'S LIABILITY IS LIMITED TO US\$10,000 IN TENDERING THIS SHIPMENT. SHIPPER AGREES THAT ARAMEX SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE CARRIAGE HEREOF. ARAMEX DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED WITH RESPECT TO THIS SHIPMENT.
